• 2024 Workplan – Commissioner Rumsey stated the levy rate should be set at 0.65%. To raise the rate, it must be approved by the Commissioners. The numbers reflect

the TIF Assessment. The newly revised Workplan budget would be shared with the Commissioners. The approved budget due date is July 14th.

SSA Audit – Approved on June 11th at a special meeting without findings.

SSA Presentations – Clarence Davids and Brightview
